WHAT IS THE DARKWEB

The dark web is a hidden part of the internet where cybercriminals buy, sell, and trade stolen data, like your passwords, email logins, and financial information. It's not searchable on Google or visible in your browser, but it's where your company's risks can silently grow.

WHY DOES THIS MATTER?

**When your data is exposed on the dark web,
the risks can include:**

- **Hacked accounts:**
Cybercriminals use stolen logins to break into your systems.
- **Customer trust erosion:**
Customers lose trust fast after a breach.
- **Costly downtime:**
Attacks can freeze operations and drain resources.
- **Ransomware lockdowns:**
Leaked logins are a common doorway for ransomware.

Cybercriminals don't just sell stolen data—they exploit it. The source of the exposure is key in determining the cause and potential attack vectors, allowing you to understand how and why your data was compromised. Without this context, businesses remain reactive rather than proactive.

Recent trends underline these dangers. Ransomware has surged with 92% of organisations affected by ransomware in the past year, and 62% of those hit ended up paying a ransom, with demands often exceeding \$1 million (average ~\$4.3M).
